Description, continued: posts, squared wood balusters, jigsawn brackets; imbricated shingles in gable ends; jigsawn sunburst motif in gable ends; window surrounds w/ crown molding.

Significance, continued: similarly detailed houses still stand in the city, this is one of the best preserved. The unusual roof line, one of the structure's most distinctive elements, includes a steeply pitched hip roof that extends over much of the house and also gabled and clipped-gable extensions. The original jigsawn- and turned-wood detailing remains in good condition.
