

DESCRIPTION - MCKINNEY RESIDENTIAL HISTORIC DISTRICT

The McKinney Residential Historic District, northwest of the city's central business district, encompasses a cohesive grouping of domestic buildings, including some of the finest local examples of vernacular, Popular and High-Style architecture. The most significant concentrations occur along W. Hunt, N. College, W. Louisiana and W. Virginia streets. The majority of contributing structures were built between 1895 and 1930, although a small number of those in this category were erected immediately before or after this period. Few post-1936 structures stand within the district.

Despite its close proximity to the downtown area, this neighborhood was developed over a long period of time and in a somewhat piecemeal fashion. The streets follow a grid pattern and conform to the orientation of those in the original town site. However, the lots and blocks in this residential area are much more irregular in size than those in the old part of town. The land slopes gently to the east and the most distinctive geographic feature is an old creek bed which extends through the eastern half of the district and runs parallel to and between N. College and N. Benge streets. Tree plantings along the 400 to 500 blocks of W. Hunt Street are the most significant landscaping elements, and their placement in an orderly and systematic manner contributes to the visual cohesiveness of the neighborhood.

The architectural evolution of this neighborhood parallels that for much of the rest of the city's residential areas. The F.M. "Tuck" Hill House (Site No. 403), built in 1877, is representative of the first type of permanent residences built in the neighborhood and is the oldest structure within the district. It has pedimented architraves above each of the window and door openings, as well as a steeply pitched gable roof and other features, such as chamfered wooden porch posts, which are typical of other local examples of the I-house configuration.

During the late nineteenth century, McKinney residents began to build houses that were much more elaborate in detailing and style. Often, traditonal vernacular forms were embellished with ornate jigsawn, gouged and turned wood detailing, such as the house (Site No. 388) at 503 W. Hunt Street. In other cases, architects and/or skilled contractors designed and built more stylish residences. The Queen Anne mode was most popular of that era, and several noteworthy examples stand within the district. The Charles and Sallie Heard House (Site No. 358), designed by local builder/architect

John Martin, and the Aron-Morris House (Site No. 382), erected from plans provided by New York architect Putnam Russell, are indicative of the sophisticated residences built by some of McKinney's wealthiest citizens of the late nineteenth century. Both houses reflect the prevailing architectural preferences for irregular massing and a rich variety of textures and materials so characteristic of the Victorian period.

Architectural trends became more diverse during the early years of this century, and many styles and types of houses were built, locally and throughout the nation. Several residences in the northwest section of town exhibit influences of the Classical, Colonial and Georgian Revival styles, all of which typically feature a symmetrical appearance and classically inspired detailing. The John and Rachel Heard House (Site No. 1113), with its two-story pedimented portico and Corinthian columns, is the best example not only in the district, but also in the entire community. During the 1910s, the Prairie School Style became a favorite among local residents, and while no "pure" examples of this architectural mode were built in McKinney, numerous residences exhibit features that are characteristic of the movement. Almost all local examples stand within this historic district. The low-pitched roofs and broad eaves of the J. W. Barnes House and the Fox-Caldwell House (Site Nos. 453 and 1114, respectively) are indicative of the Prairie Style.

Bungalows, in their many varieties and types, are the most common house-type found in the historic district. Some are extremely well-crafted and were designed by architects for a specific client. Research has yet to identify any architect-designed bungalows in the district. More likely, bungalows were built from plans that appeared in pattern books which were available at any of the local lumberyards. The earliest are among the best local examples of bungalows, such as the J.W. Fields House (Site No. 456) at 602 W. Louisiana Street but later versions, which are more numerous, exhibit only minor stylistic influences of this popular architectural expression. Examples includes houses at 608 W. Virginia (Site No. 405) and 611 W. Virginia (Site No. 431).

Residential construction in this neighborhood since 1936 has been limited. The most intrusive element is a one-story brick building at the northwest corner of W. Virginia and Benge streets, but its impact on the overall historic character of the area is minimal. Most of the noncontributing structures are modern residences that have been built since 1937. Several historic frame houses have been unsympathetically altered with the application of aluminum or vinyl siding, but most still retain at least some of their significant architectural detailing. During the last two years, many citizens have recognized the uniqueness of this neighborhood and have undertaken successful restoration projects on their residences.

One of the city's finest bungalow residences. Former home of A.H. Eubanks, who was a cashier at the Central State Bank of McKinney.

H.H. and Margaret Neilson House. 2-story frame dwelling with four-square plan; low-pitched hipped rof with hipped dormer; wide overhanging eaves; l-story L-shaped porch; front entrance with sidelights; Former residence of Horace H. Neilson, a prominent local attorney who also served as county attorney, county judge and state legislator during his many years in office.

- Site No. 364. 506 W. Hunt. Contributing: ca.1910. Fred Emerson House. 2-story frame dwelling; low-pitched hipped roof; l-story L-shaped porch with Doric columns; small inset balcony on second level of southeast corner. In plan, this house appears to be a variation of an American four-square dwelling, although many of its details, such as the portico and columns, are typical of Classical Revival architecture. This was the former home of Fred Emerson, who was vice president of the First National Bank of McKinney.
- Site No. 365. 502 W. Hunt. Contributing: ca. 1930. 1 1/2-story frame dwelling with brick veneer; steeply pitched, cross-gabled roofs. One of the city's best examples of Tudor Revival architecture, a common style of the 1930s.
- Site No. 376. 707 W. Hunt. Contributing: ca. 1920. 1-story frame dwelling; gable roof; stick brackets and exposed rafter ends; bungalow details.
- Site No. 377. 705 W. Hunt. Contributing: ca. 1935. 1-story frame dwelling; gable roof; double-hung windows w/ 6/6 lights; small entry porch at NE corner.
- Site No. 378. 617 W. Hunt. Contributing: ca. 1885. 1-story frame dwelling w/ L-shaped plan; cross-gable roof; slightly pedimented architraves over double-hung windows; 4-bay porch across N. elev.; possibly the east wing is a later addition onto an older 1-story, center-passage dwelling; one of the oldest houses in the district.
- Site No. 379. 613 W. Hunt. Contributing: ca. 1910. 2-story frame dwelling w/ modified L-plan; hip roof w/ hipped extensions; metal finial atop apex of hip roof; 1- and 2-story porch w/ Doric-like columns; single-door entrance; double-hung windows w/ 1/1 lights; second-floor porch is a small balcony above front entrance; a noteworthy example of an early twentieth-century dwelling in McKinney.

One of the city's most outstanding examples of Queen Anne architecture. It was built for Morris and Henrietta Aron, a merchant who sold the house and returned to New York in 1895. In 1897 Plummer and Josie Harris purchased the house, which remained in the family until 1951.
- Site No. 383. 521 W. Hunt. Contributing: ca. 1920. 1- and 2-story frame dwelling; gable roof with exposed rafter ends and stick brackets; 1- story L-shaped porch with paneled box supports; horizontal massing and details are characteristic of the bungalow style -- a good local example.
- Site No. 384. 519 W. Hunt. Contributing: ca. 1902. Dr. G.H. Provine House. John Martin, architect. 1 1/2-story frame dwelling with modified L plan; hip roof with gables; 1-story L-shaped porch. This is a good example of one of the most popular vernacular house-types of turn-of-the-century McKinney. Built for G.H. Provine, a local physician.
- Site No. 385. 515 W. Hunt. Contributing: ca. 1910. N.A. and Lara Burton House. 1 1/2-story frame dwelling; hip roof with hipped dormer; wide overhanging eaves with consoles; 1-story porch with pedimented portico that projects from central bay. A good illustration of a hip roofed bungalow, this house, however, exhibits some Classical Revival detailing. Built for N.A. Burton, who was a wholesale grain and produce dealer. He also served as county commissioner from 1902 to 1906.
- Site No. 386. 509 W. Hunt. Contributing: ca. 1920. 1-story frame dwelling with double-gabled front; bungalow details include exposed rafter ends, stick brackets and tapered box porch supports.
- Site No. 387. 505 W. Hunt. Contributing: ca. 1920. 2-story frame dwelling with brick veneer; hip roof with wide overhanging eaves; 1-story 1-bay entry porch offset from center. A variation of the American four-square house-type.

STATEMENT OF SIGNIFICANCE - MCKINNEY RESIDENTIAL HISTORIC DISTRICT

The McKinney Residential Historic District includes the city's most intact historic residential neighborhood. Most of the dwellings were built in the late nineteenth or early twentieth centuries, and only a small number of post-1937 structures are found within the district. Some of the town's most outstanding examples of residential architecture can be seen in this area. Because of its location near the city's commercial center, this neighborhood attracted a large number of McKinney's wealthiest and most prosperous citizens, many of whom were involved in retail or commercial trade. Among the more important were merchants Charles and John Heard, J.D. Stiff and E.A. Newsome. The majority of the town's professional class also resided in this neighborhood, including Gideon Abernathy, Fred Emerson, Dr. O.H. Kirkpatrick, Dr. W.T. Hoard and others. Of the 115 structures in the district, 91 are classified as contributing to the historic character of the district.

The neighborhood evolved slowly over a long period of time and presents a variety of architectural styles and types. This pattern of development is indicative of the relative stability of the town's growth. Unlike other towns of comparable size and age in the region — Waxahachie for instance — McKinney avoided the pitfalls of a boom—and—bust economy, which is most often characterized by a period of intense short—term speculation, followed by a sharp downturn in activity.

DEFINITION OF CATEGORIES - MCKINNEY RESIDENTIAL HISTORIC DISTRICT

Contributing - Properties in this category include structures that add to the historic character of the district. These buildings are at least 50 years old, yet most were constructed between 1895 and 1930. Properties in this category retain most of their important historic architectural features, and more recent changes have been minor and relatively unobtrusive. In one case (the Newsome House - Site No. 433), asbestos siding has been applied over the original wood siding. Despite this alteration, the structure still retains its historic integrity and is, therefore, classified as contributing. The most common alterations seen among houses in the district involve changes to the porch. Wooden porch floors often rot and are then replaced with concrete floors. Many residents have replaced their original wooden porch supports w/ decorative wroughtiron supports, which are not sensitive to the historic character of a house. As a rule, however, these changes are not severe enough to justify the structure's classification as a noncontributing.

Noncontributing — Structures within this category include those that 1) are not 50 years old and thus do meet National Register criteria, or 2) were built before 1936 but have been so severely altered that their historic character and integrity has been compromised.

JUSTIFICATION OF BOUNDARIES - MCKINNEY RESIDENTIAL HISTORIC DISTRICT

The McKinney Residential Historic District includes a cohesive grouping of late nineteenth- and early twentieth-century dwellings, northwest of the city's central business district. Late 1930s and early 1940s structures abound in the area to the west of the district. Modern commercial buildings, parking lots and other non-historic, non-residential properties abut the district's east and northeast boundaries. The residential neighborhood to the south, however, includes several historic dwellings, but, if included in the district, the large number of modern (post-1937) residences (which would be regarded as intrusive elements) would have a negative effect on the district's overall historic character. A similar argument is made for the neighborhood to the north of the district. Although this area contains a large number of historic houses, many of which are being nominated individually, noncontributing properties detract from the neighborhood's historic character. This area was included in the district when originally submitted to the State Board of Review, but the board members felt that the impact of many intrusive elements in this section of town were negative and should be excluded from the district. In addition, the board members argued that the area to the north of the district did not possess the cohesiveness present in the territory being considered for nomination as a historic district.






