12. Significance ARCHITECTURE: The elaborate jig-sawn and spindled woodwork distinguish this house as one of Cuero's most intact late 19th-century dwellings. Virtually unaltered, it was built for Albert and Kate Leinhardt in 1891.
13. Relationship to Site: Moved? Date ca. 1895 or Original Site (describe) in a residential area east of the CBD; in the middle of the north side of the block.

Description continued: posts and balusters; jig-sawn brackets; spindled porch frieze; intersecting gables w/ paired windows and imbricated shingles in front gables; 3-sided bay projects from W. elev.; 4-bay porch on W. elev. w/ detailing similar to facade porch; shed addition to rear; imbricated shingles in all gable ends.

Significance continued: The house remained in the Leinhardt family through the 1930s.
