Description continued: frieze; 2 interior brick chimneys w/ corbeled caps; large gable on front-projecting wing extends to front porch; squared-bay extends from second floor of front-projecting wing; art-glass in front entrance; cutaway corners on first floor of E. elev. 2-story rear porch similar in detailing to that of front porch.

Significance continued: nearby Jackson County. Burns maintained extensive landholdings in Jackson, Borden and Dawson counties, raising livestock on the lands. This structure is a noteworthy local example of Victorian domestic architecture.
